In compliance with art. 12 of Resolution of the Securities and Exchange Commission ("CMV") No. 44, of 2021 ("RCMV 44/21"), (i) ANDES VENTURES LLC, a limited liability company organized under the laws of Delaware, United States of América, EIN N°93-4339987, domiciled in 1209 Orange Street, in the City of Wilmington, County of New Castle, Delaware, United States of America, CNPJ N° 53.124.684/0001-08 ("Andes Ventures"), (ii) INVERSIONES GALILEA S.A., a corporation organized under the laws of Chile, RUT N° 76.098.247-4, domiciled in Avenida Américo Vespucio Norte 2500, piso 7, comuna de Vitacura, Santiago, Chile, CNPJ N° 50.225.769/0001-86 ("Galilea"), and (iii) IG VENTURES S.A., a corporation organized under the laws of Chile, RUT N° 79.574.560-2, domiciled in Avenida Américo Vespucio Norte 2500, piso 7, comuna de Vitacura, Santiago, Chile, CNPJ N° 50.165.068/0001-07 ("IG Ventures" and, together with Andes Ventures and Galilea, the "Group Companies"); hereby inform Infracommerce CXAAS S.A. ("Company") that:

1. On this date, (i) Andes Ventures holds 146,378,148 registered shares, common, nominative and with no par value issued by the Company, equivalent to approximately 8.12% of the total common shares, book-entry, nominative and with no nominal value issued by the Company; (ii) Galilea holds 17,829,737 registered shares, common, nominative and with no par value issued by the Company, equivalent to approximately 0.99% of the total common shares, book-entry, nominative and with no nominal value issued by the Company; and (iii) IG Ventures holds 27,261,781 registered shares, common, nominative and with no par value issued by the Company, equivalent to approximately 1.51% of the total common shares, book-entry, nominative and with no nominal value issued by the Company;

2. The Group Companies do not hold, directly or indirectly, on this date, other shares or securities (including derivatives) issued by the Company, except 34,563,469 debentures issued by the Company under the Private Instrument of Indenture of the 3rd (Third) Issuance of Debentures Convertible into Shares, of the Secured Type, with Additional Surety Guarantee, in 2 (Two) Series, for Private Placement, of Infracommerce CXaas S.A., executed on April 13, 2025, as amended on June 3, 2025.

3. The objective of the participation is investment and participation in the Company's administrative structure, through the eventual appointment of 1 (one) member of the Company's Board of

Directors. However, the participation is not intended to change the composition of the Company's control; and

4. The Group Companies are not part of any other agreement or contract regulating the exercise of voting rights or the purchase and sale of securities issued by the Company.
