Infracommerce announces change of Auditor

São Paulo, April 24, 2025: Infracommerce CXaaS S.A. ("Infracommerce" or "Company") (B3:IFCM3) informs its shareholders and the market in general that it has engaged Grant Thornton Auditores Independentes Ltda., enrolled with the CNPJ/MF (Corporate Taxpayer's Register of the Ministry of Finance) under No. 10.830.108/0001-65 (CVM Code No. 11274), as the new independent auditor of the Company, replacing KPMG Auditores Independentes, due to the unification of efforts and optimization of resources. This decision was made considering that Grant Thornton Auditores Independentes Ltda. is already acting as the local auditor for operations in other Latin American countries, with the exception, until now, of the Brazilian operation and the restated financial statements. In addition, the Company has brought forward by one year the mandatory rotation provided for in Article 31 of CVM Resolution No. 23/2021.

KPMG Auditores Independentes, the auditing firm being replaced, has stated its agreement with the rationale for the change made.

Grant Thornton Auditores Independentes Ltda. will begin its activities starting with the review of the quarterly financial information (ITRs) for the first quarter of 2025.
